- 1) Approval of March 4 draft minutes
    - **Irving moved to adopt, seconded, adopted**
  - 2) Business arising from March 4 meeting
    - **Carl to re-circulate governance paper with revisions**
  - 3) Project Proposal Update
    - four proposals submitted under auspices of the Centre to Canadian Forest Service Mountain Pine Beetle program
    - three proposals submitted to FII under auspices of the Centre
    - Next major funding opportunity is Softwood Lumber Adjustment
    - Program criteria are expected soon. Bulkley Valley is eligible, and Sharon Robertson of Nadina has indicated that some of the work of the Centre would be eligible
    - This may be a chance to revise and resubmit the original Vancouver Foundation proposal, to get start-up funds for the Centre
    - Submitting a quality proposal in short times will require some dedicated effort.

## List of Proposals Submitted to Date

### **Canadian Forestry Service (CFS) – Mountain Pine Beetle (MPB) Initiative**

A Natural Disturbance-based Experimental Framework for Monitoring and Understanding Ecosystem and Successional Responses to Mountain Pine Beetle Epidemics.

*BV Centre would be the project manager in all cases.*

1. A retrospective study using permanent research plots.  
-project leaders: Jim Pojar, Phil Burton  
-1 year; \$95,000
2. Plot establishment, management treatments, and outbreak monitoring in new permanent research plots.  
-project leader: Phil Burton  
-5 years; \$508,000
3. Vegetation, regeneration, microclimate, nutrients, and hydrological monitoring.  
-project leader: Phil Burton  
-5 years; \$492,000
4. Stand-level modeling of silvicultural strategies in MPB-damaged stands.  
-project leader: Dave Coates  
-2 years; \$124,000

### **Forestry Innovation Investment (FII)**

- 1) Managing Forest Stands and Landscapes for Snowshoe Hares and Lynx.  
-proponent: BV Centre  
-lead researcher: Don Reid  
-2003/04 - \$66,000
- 2) Growth Prediction of Canopy Trees in Complex Structured Mixed-Species Stands.  
-proponent: BV Centre  
-lead researcher: Dave Coates  
-2003/04 - \$85,000
- 3) Effects of Thinning and Fertilization on Subalpine Fir (*Abies lasiocarpa*)  
-proponent: West Fraser Mills Ltd., Pacific Inland Resources Division (PIR)

-BV Centre a “partner” (in FII parlance), not a “collaborator”; therefore we wouldn’t levy the administration fee

-BV Centre supports the proposal in principle, and agrees to assist in data analysis and report preparation, as well to provide advice and counsel regarding scientific rigour, on two conditions

- PIR becomes a member of the Centre (not yet)
- the proposed budget identifies funds to cover the involvement of the Centre, and publication of the results in a suitable peer-reviewed journal (such funds have been included)
